TERMS AND CONDITIONS

1. A credit card is required to rent a vehicle. Payment in full may be made by Cash, Travelers Checks, Visa or Master Card. Cash payments are taken only at vehicle return time and credit card charge will be refunded (less deposit).
2. All drivers must have a valid U.S driver's license and a credit card in the same name in order to reserve a vehicle. Renters with a valid non-U.S. driver's license will be required to purchase a Virgin Islands Temporary Driver's License in the amount of \$17.00 for 90 days. In order to purchase a Virgin Islands Temporary Driver's License, the driver will need to present his/her current U.S. government issued VISA card and valid driver's license
3. All drivers must meet the minimum age requirement of 25 years of age.
4. The rented vehicle shall not be operated by any person other than the Renter. If Renter allows any other driver under the age of 25 years old to drive the vehicle, the Renter will be fully responsible for all expenses relating to the rental car and any other vehicle involved in any type of accident.
5. The daily government tax is an additional \$3.75. Subject to change anytime.
6. All rental jeeps will be provided with a full tank of gas. Renter is required to return the vehicle with the same amount of gas. If Renter returns the vehicle with less gas than when the vehicle was first rented, then Renter will be charged \$7.00 per gallon, plus a service charge of \$15.00.
7. All front seat passengers **MUST** wear seat belts at all time.
8. Children under the age of 5 years old or under 40 pounds must be secured in a child seat, according to the V.I Law.
9. If the Rental Agreement is broken, the vehicle is returned early or confiscated due to the Renter violating the terms and conditions, the Renter is still responsible for the entire cost of the rental vehicle.
10. The vehicles must be closed and locked when unattended. Be sure windows are closed for security and to prevent rain damage to the vehicle interior.
11. Just Sun Rentals is not responsible for any personal articles left in the vehicle, either during the rental or after the vehicle is returned.
12. Brush off excess sand at beach before entering the vehicle. Wet and/or sandy interiors are subject to charges starting at \$175.00 for excessive cleaning.
13. Removal of the Jeep Wrangler tops is a \$500.00 fine and reason for confiscation of vehicle.
14. Replacements electronic keys are \$300.00 per key.
15. Renter is responsible for all parking fines and traffic violations. If processed by Just Sun Rentals there will be a service charge that will be added to the cost of the fine, in the amount of \$75.00.
16. If the vehicle is involved in an accident, the Renter agrees to make a report to the police and submit a copy of the police report to Just Sun Rentals.
17. Insurance is null and void if Renter drives the vehicle on unpaved roads.
18. The Renter shall not operate the vehicle in a negligent manner.
